FUND OBJECTIVE

This Fund invests in a range of different underlying asset classes. Its investment objective is to achieve 2% p.a. more than inflation when your Pension Account is invested solely in Fund C AVC – when you are between 5 and 3 years from your Selected Retirement Age "SRA". Once within 3 years of your SRA, your Account is invested in a mix of Fund C AVC and the Cash Fund AVC, and possibly the Gilt Fund AVC too, depending on the investment option you choose. This Fund is available to members who decide to pay additional voluntary contributions (AVCs). It is not available to Hybrid Section members.

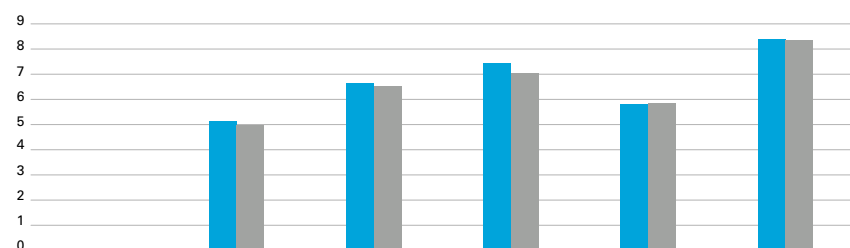

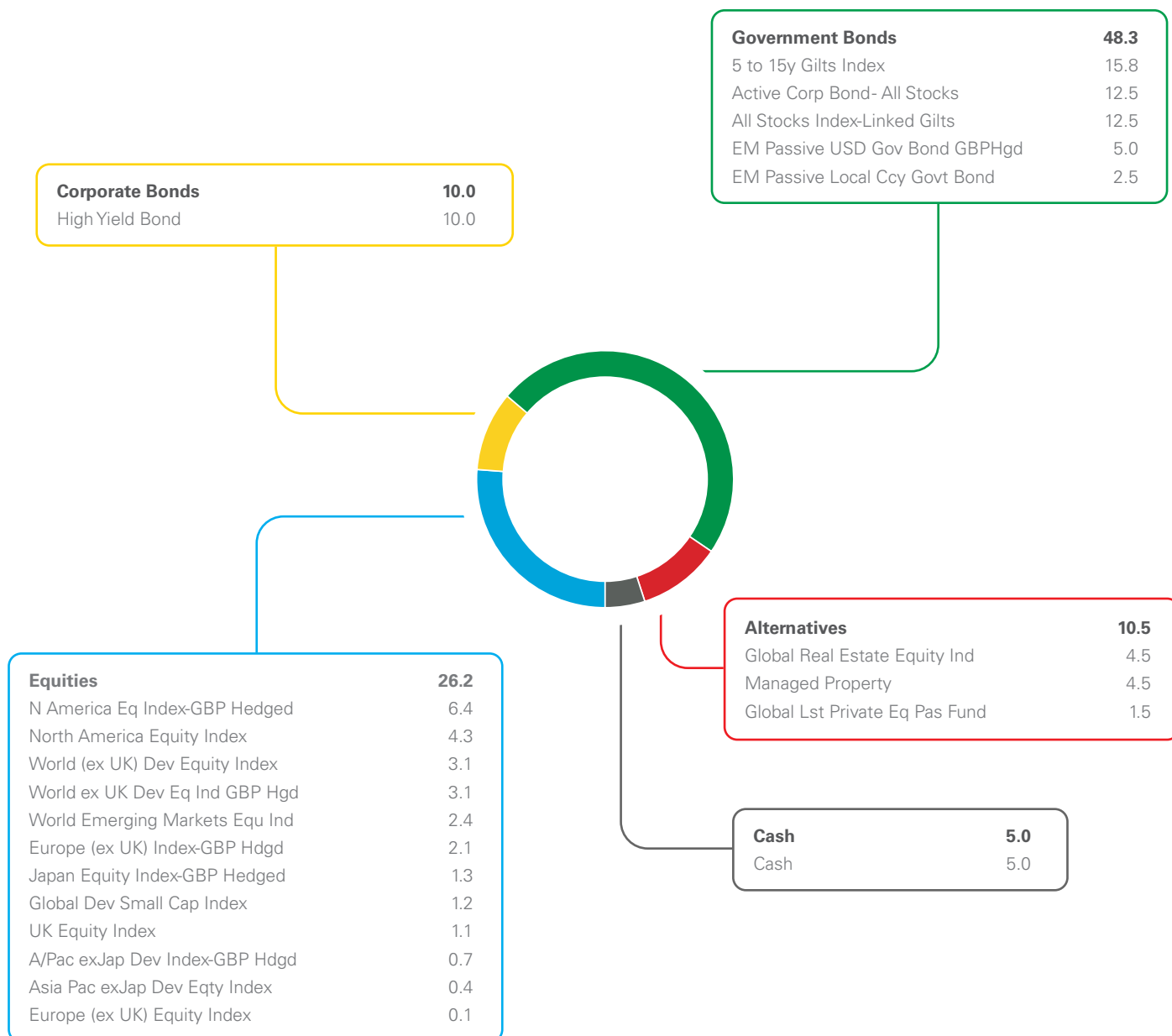
